PRESIDENT BETH SESSIONS ATTENDED NATION NENA IN PITTSBURGH IN JUNE. SHE STATED IT WAS VERY INFORMATIVE.

THE BOARD MADE A UNANIMOUS DECISION TO APPOINT GARY ELDRIDGE AS A LIAISON TO NATIONAL NENA FOR GOVERNMENT ISSUES THAT HAVE AN EFFECT ON PSAPS. HE WILL BE PART OF WEEKLY OR MONTHLY CONFERENCE CALLS AND OTHER DISCUSSIONS PERTAINING TO THESE ISSUES.

THE ENHANCE 911 ACT WAS IMPLEMENTED IN 2004 YET, TO DATE NO MONIES HAVE BEEN APPROPRIATED BY CONGRESS FOR THE GRANT PROGRAM. NENA IS REQUESTING ALL MEMBERS GO TO THE NATIONAL NENA WEBSITE, CLICK ON ENHANCE 911 ACT

APPROPRIATIONS: CALL TO ACTION AND PRINT OFF A LETTER TO SEND TO YOUR SENATORS ON THE IMPORTANCE OF PROVIDING FUNDING FOR E911. THE MONIES SHOULD COME OUT OF THE TRANSPORTATION BILL WILL BE CONSIDERED THE WEEK OF JULY 17TH AND THE COMMERCE APPROPRIATIONS BILL WILL BE CONSIDERED THE WEEK OF JULY 10TH. TIME IS SHORT!

THE BOARD DISCUSSED INVITING THE NOMINEES FOR STATE TREASURER TO THE OCTOBER QUARTERLY MEETING TO SPEAK. THIS SEAT IS IMPORTANT BECAUSE THE STATE TREASURER IS ALSO THE HEAD OF THE WIRELESS 911 BOARD.

THE BOARD DISCUSSED THE POSSIBILITY OF HOLDING INFORMATIVE SPECIAL SESSIONS ON SUCH TOPICS AS VOIP AND WIRELESS DIRECT. THE CLASSES WOULD BE HELD IN A CENTRAL LOCATION. THE BOARD IS LOOKING INTO HOLDING SOME TYPE OF TRAINING CLASSES IN THE FALL. THE CLASSES MAY POSSIBLY BE HELD IN BOTH THE NORTHERN AND SOUTHERN PARTS OF THE STATE. A THIRD CLASS

MAY ALSO BE HELD IN CENTRAL INDIANA. IF ANY MEMBER HAS ANY SUGGESTIONS FOR THE TYPE OF TRAINING PLEASE CONTACT ONE OF THE BOARD MEMBERS WITH YOUR IDEAS.

ROB MCMULLEN IS LOOKING INTO THE POSSIBILITY OF AWARDING A SCHOLARSHIP TO A NENA MEMBERS CHILD. TRINA WINEGARDNER WILL ASSIST HIM IN GATHERING INFORMATION. A DECISION WILL BE MADE BY THE BOARD WHEN ALL INFORMATION HAS BEEN SUBMITTED
